- To help field officers and law enforcement administrators understand the legal requirements and implications of mandatory line-up protocols;
- To help field officers and law enforcement administrators assemble live and photo line-ups that comply with the mandates of ILCS 5/107A;
- To help field officers and law enforcement administrators proactively deal with the realities and exigencies of conducting line-ups when compliance with 107A is not practicable or feasible.
