

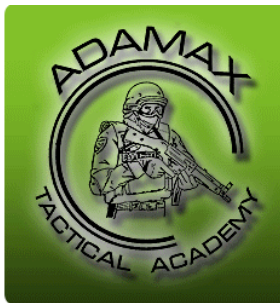

ADVANCED RAPID DEPLOYMENT

Prerequisite: Completion of the Basic Rapid Deployment course instructed by this instructor, or a similar rapid deployment course teaching the “diamond formation” method.

Instructor: Ron Yanor, ADAMAX, Inc.

About the course: Advanced Rapid Deployment is the next progression for immediate action tactics training. It examines core topics in depth and broadens the scope to include new formations, pre-deployment and reorganization tasks. Training is hands-on and practical; with numerous drills and exercises. The class ends with a interactive FTX.

Stairwell Drills & Complex room clearing
Officer Down Drills
2 & 3 Formations
Advanced Formations
Handling Victims
Centralize & Evacuate
Approach Phase Tasks

Each student will be performance checked on individual tasks before moving to the next drill. Team drills are realistic and safe for maximum effect.

Students will need to bring: Duty belt, pistol, long gun (if issued), flashlight, any other equipment normally carried on patrol. **DO NOT BRING:** Magazines, ammo, OC spray, FBG’s, pyro. **CLASS WILL BE HELD RAIN OR SHINE, SO DRESS FOR THE WEATHER.**
